- 1. A confirmation deposit of 50% is required to hold your date & services.**
- 2. The remaining balance is due 5 business days before the date of the event.**
- 3. All Star accepts cash or interact. This contract is not binding until All Star has received the 50% deposit which is non-refundable 30 days prior to your event. Any cancellations must be submitted in writing.**
- 4. The minimum order of twenty five (25) is required for all food orders.**
- 5. The final guest count is to be confirmed 72 hours prior to your event. If attendance falls below the guaranteed number the client will be charged for the initial minimum guaranteed number.**
- 6. Rental orders and invoices are the responsibility of the client. All Star agrees to hold rentals before the event, during the event and after, for pick up.**
- 7. Should your event require additional permits and insurance these costs will be incurred by the client and paid by the client with proof of payment provided to the venue 5 days before the event.**
- 8. Gratuity of 18.5% will be added to parties of 10 or more.**
- 9. Suite exclusivity based on parties of 20 plus guests.**
- 10. The customer is required to provide a valid credit card incase of damage, loss or late return of all rental items, venue damage or charges and to secure outstanding balance of monies owed due to event venue rental, food or bar charges.**
